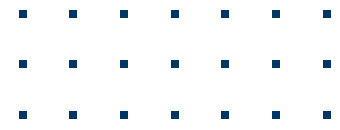

Board members must demonstrate a deep commitment to NEW’s mission: empowering Georgia’s workforce and military families through affordable, sustainable homeownership and holistic community support.

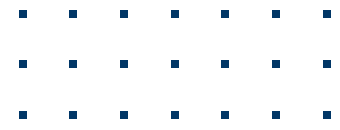
## Professional Expertise

## Community Representation

NEW values a Board that reflects the diversity of Georgia’s workforce, including essential workers, military families, and those from underrepresented backgrounds.

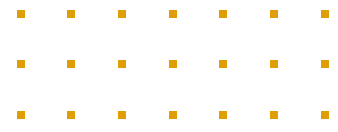
# Board Expectations



- 1 Term of Service - Board members serve a two-year term and may be reappointed based on performance and organizational needs.
- 2 Active Engagement - Attend at least 90% of scheduled Board and committee meetings, whether in-person or virtually. Prepare for meetings, participate thoughtfully, and contribute your expertise.
- 3 Strategic Leadership - Provide guidance and oversight for NEW's mission, vision, and long-term goals, including the success of the Kingdom Village project.
- 4 Governance and Accountability - Uphold high ethical standards, transparency, and compliance with all laws and regulations. Participate in periodic governance training and annual self-assessment.
- 5 Financial Stewardship - Review and help approve budgets and financial statements. Support fundraising, including an annual personal contribution and outreach efforts
- 6 Advocacy and Ambassadorship - Act as an ambassador for NEW's mission, representing our work to stakeholders, partners, and the community.
- 7 Committee Participation - Serve on at least one committee—such as Finance, Development/Fundraising, Community Engagement, or Housing/Construction.
- 8 Conflict of Interest and Confidentiality - Disclose any conflicts of interest, avoid related deliberations, and keep sensitive information confidential.
- 9 Continuous Learning - Stay informed about trends and best practices in housing, community development, and nonprofit governance. Participate in relevant training and professional development.



# Commitment to Financial Stewardship



## Personal Contributions

Each board member is asked to commit \$20 per month (\$240 per year) to NEW, affordable for working professionals and symbolic of our shared investment.

We ask board members to help raise an additional \$500 annually through connections, outreach, and grassroots fundraising.



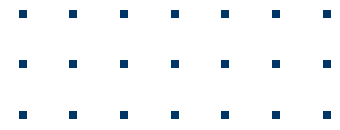

## Our Board Committees



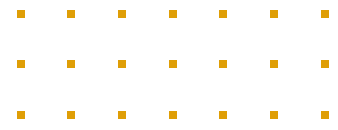
We invite candidates to bring their skills to our committees in the following areas:

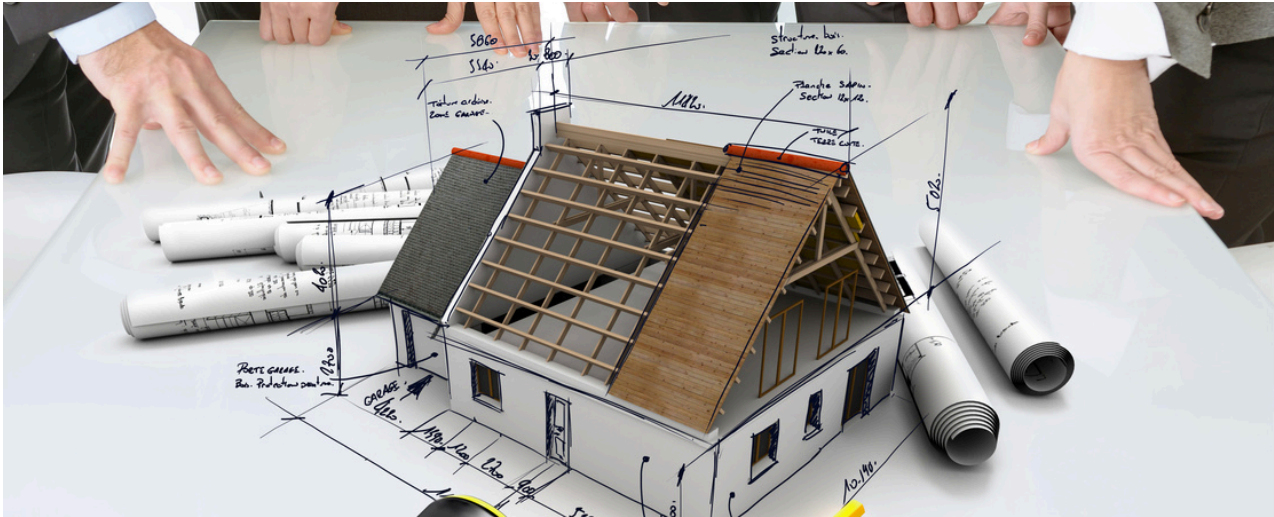
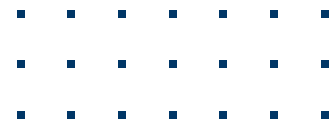
